- 1. A document describing the composition of cosmetic products, certified by the manufacturer;
- 2. Standards, regulations, technological instructions, in accordance with which the products were manufactured, which were certified by the manufacturer;
- 3. Copies of packaging (labels) or their layouts certified by the applicant;
- 4. Documents that describe the technical process of production (if any);
- 5. Quality Management System Certificate (if any);
- 6. Certificate of registration with the tax authority of the applicant (manufacturer);

Documents Required for Perfumery and Cosmetics Declaration Manufactured Outside the Eurasian Customs Union (EACU):

- 1. A document describing the composition of cosmetic products, certified by the manufacturer;
- 2. Standards, regulations, technological instructions, in accordance with which the products were manufactured, which were certified by the manufacturer;
- 3. Copies of packaging (labels) or their layouts certified by the applicant;
- A document confirming the safety and quality of the test samples, certified in accordance with the legislation of the Party conducting the state registration (if any);
- 5. Documents that describe the technical process of production (if any);
- 6. Quality Management System Certificate (if any);
- 7. Documents confirming consumer properties declared on the packaging of the perfumery and cosmetics, certified by the applicant.
- 8. Contract (agreement) with the manufacturer;
- 9. Certificate of state registration of the applicant (manufacturer);
- 10. Certificate of registration with the tax authority of the applicant.
